- 3. The candidates who have appeared for the Written Examination and whose register number is not found in the above list, have not been admitted to Physical Certificate Verification and Interview for the said recruitment.

The admission of the above candidates to the Interview is purely provisional subject to the decision of the District Recruitment Bureau and subject to the outcome of final orders to be passed in cases, if any, pending on the files of the Hon'ble High Court of Judicature at Madras/Madurai Bench of Madras High Court relating to this recruitment.

Candidates who have been admitted provisionally to the Physical Certificate Verification and Interview are hereby advised to attend the Physical Certificate Verification and Interview with all the relevant documents in original, without fail. Failure to produce even any one of the essential documents will result in their non-admission to Physical Certificate Verification and Interview for the said recruitment.
